ordinance no. 6

AN ORDINANCE prohibiting the sale of intexicating liquors and beverages within the Town of Greenwood between the hours of midnight Saturday night and six a.m. Monday morning.

BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF GREEN-WOOD. FLORIDA:

Section 1. That hereafter it shall be unlawful for any person to sell or cause to be sold, between the hours of midnight Saturday night and six o'clock a.m. Monday morning, any intoxicating liquors, wines or beer in the Town of Greenwood, Florida.

Section 2. Any person who sells or causes to be sold, any intoxicating liquors, wines or beer in the Town of Greenwood between the hours of Saturday night midnight and six o'clock am. Monday morning, shall, for such offense, upon conviction, be punished by a fine not exceeding \$250.00, or by imprisonment at hard labor on the streets or other public works of the Town for not more than ninety (90) days, or both, at the discretion of the Mayor.

Section 3. This ordinance shall become effective on the 10 day of 15. A. D. 1954, and shall be published by posting in three public places in the Town of Greenwood, one of which shall be at the office of the Town Clerk.
