

## **ORDINANCE 2012-01**

**AN ORDINANCE OF THE TOWN OF GREENWOOD, FLORIDA; RELATING TO AN ANNUAL UPDATE TO THE TOWN OF GREENWOOD FIVE YEAR SCHEDULE OF CAPITAL IMPROVEMENTS; PURSUANT TO PROCEDURES ESTABLISHED IN SECTIONS 163.3161 THROUGH 163.3177, FLORIDA STATUTES; UPDATING THE FIVE YEAR SCHEDULE OF CAPITAL IMPROVEMENTS FOR THE FISCAL YEAR 2012/2013 THROUGH 2016/2017; PROVIDING SEVERABILITY; REPEALING ALL ORDINANCES IN CONFLICT; AND PROVIDING FOR AN EFFECTIVE DATE.**

**WHEREAS**, Section 163.3177, Florida Statutes, requires the schedule of capital improvements must be reviewed on an annual basis and modified as necessary in order to maintain a 5-year schedule of capital improvements; and

**WHEREAS**, the Planning Commission, did on October 30, 2012 hold, after appropriate public notice thereon, a public hearing on said schedule of improvements, as described below, to the Town of Greenwood's Five Year Schedule of Capital Improvements; and

**WHEREAS**, at said public hearing the Planning Commission, reviewed and considered all comments received during said public hearing, reviewed and considered the staff presentation concerning said schedule of improvements and recommended approval of said schedule of improvements, as described below; and

**WHEREAS**, the Town Council on December 11, 2012, did hold the required public hearing for adoption of the ordinance, after appropriate public notice thereon, as described below, and did update the Town of Greenwood's Five year Schedule of Capital Improvements; and

**WHEREAS**, At said public hearing, the Town Council, reviewed and considered all comments received during the public hearing, the Planning Commission recommendation and the staff recommendation, as described below; and

**WHEREAS**, the Town Council has determined and found said application for amendments, as described below, to the Town of Greenwood's Five year Schedule of Capital Improvements to be compatible with other affected elements of the Town's Comprehensive Plan goals, objectives and policies; and

**WHEREAS**, the Town Council has determined and found that approval of said amendments, as described below, to the Town of Greenwood's Schedule of Capital Improvements would promote the public health, safety, morals, order, comfort, convenience, appearance, prosperity or general welfare.

## CERTIFICATE OF ADOPTION AND APPROVAL

The above and foregoing ordinance was duly read and approved upon First Reading by a 3-0 vote of the Town Council of the Town of Greenwood, Florida, at a Regular Meeting held on November 13, 2012.
