ANNEXATION ORDINANCE NO 95-3

AN ORDINANCE ENACTED PURSUANT TO THE PROVISIONS OF FLORIDA STATUTES, SECTION 171.044 PROVIDING FOR THE ANNEXATION INTO THE CORPORATE LIMITS OF THE TOWN OF GREENWOOD CERTAIN REAL PROPERTY OWNED BY TERESA A.CLARK, JOHN W. DAVIS , JOHN & CHERRY NORD, CLYDE CARTER, RICHARD & SUSAN BARNES, NYLA J. PEELER, HOWARD & DONNA MCDONALD, WANDA TIDWELL, DAVID LEE BANKS, MACK & KATHRYN BANKS, GIL MCCOLLOUGH, JIMMY HAYES, BETTIE & PERRY PARKMAN, CARL & PATRICIA BRANNON, ROBERT & JOYCE HENRY , CHARLES & MELANIE DITTY, JOSEPH C. LARSEN, AND BONNIE B. SMITH have filed a Petition for Voluntary Annexation of their property as set forth herein, so as to receive the benefit of services, both governmental and proprietary, provided by the Town; and

WHEREAS, the Town Commission of the Town of Greenwood has received and filed a Petition for Voluntary Annexation submitted by and on behalf of TERESA A. CLARK, JOHN W. DAVIS, JOHN & CHERRY NORD, CLYDE CARTER, RICHARD & SUSAN BARNES, NYLA J. PEELER, HOWARD & DONNA MCDONALD, WANDA TIDWELL, DAVIDLEE BANKS, MACK & KATHRYN BANKS, GIL MCCOLLOUGH., JIMMY HAYES, BETTIE L. & PERRY M. PARKMAN, CARL J. & PATRICIA BRANNON, ROBERT & JOYCE HENRY, CHARLES J. & MELANIE DITTY, JOSEPH C. LARSEN, AND BONNIE B. SMITH as the sole owners of the real property hereinafter described, which petition does request that the Town Commission of the Town of Greenwood take such action as is necessary to annex the described property so that the same shall be and become a part of, and within the corporate limits of the Town of Greenwood; and

WHEREAS, the Town Commission has found and determined that it is reasonable and in the best interest of the Town, its inhabitants, as well as the petitioners that such property be annexed into, and become a part of the Town of Greenwood;

NOW, THEREFORE, BE IT ORDAINED BY THE TOWN COMMISSION OF THE TOWN OF GREENWOOD, FLORIDA THAT:

Section 1. Under and pursuant to the provisions of Florida Statutes, Section 171.044, the real property described as:

REAL PROPERTY DESCRIBED IN EXHIBITS "A" THROUGH " R" AND ANNEXED HERETO is hereby annexed into, and declared to be a part of and within the corporate limits of the Town of Greenwood, and entitled to share in the benefits and responsibilities of all other property located within the corporate limits of the Town of Greenwood.

Section 2. The charter of the Town of Greenwood be and the same is hereby amended so as to include and incorporate the real property described in and a part of the corporate limits of the Town of Greenwood.

Section 3. Upon the adoption of this ordinance in the manner and form prescribed by law, the Town Clerk shall certify copies and shall file the same with the Clerk of the Circuit Court in and for Jackson County, Florida, and shall also file a copy of the same with the Department of State of the State of Florida.

Section 4. This ordinance shall become effective immediately upon its adoption in the manner and form prescribed by law.
